This project will realign and rehabilitate as necessary three streets forming a loop in the downtown area of Dillingham. Project will include Main Street from City Hall to the intersection with "D" Street; "D" Street north to 2nd Street and back to City Hall. Project will also pave Kanakanak Road from "D" Street intersection to the small boat harbor entrance. Appropriate pedestrian improvements are included. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage and by improving the mobility of people and goods.

**Project Description/Justification:**

The roadways included in this project constitute a significant portion of the downtown business district of Dillingham. The existing surfaces are failing and lack adequate sidewalks. Realignment of a portion of the project will move Main Street a safe distance away from the corner of City Hall improving the overall safety of the streets and pedestrian walkways within the business district, essential to the economic well-being of the community. The City of Dillingham is contributing the land needed for realignment of the existing roadway and assuming responsibility for operation and maintenance of the State-owned Dillingham-Aleknagik Road segment from Milepost 0.0 to Milepost 0.29 (comprised of Main and 2nd Streets).
