Project Description/Justification:

The Division of Parks and Outdoor Recreation will purchase and install twenty electronic fee stations with this funding. These fee stations will be at the highest demand day-use areas, boat launches, and campgrounds. Locations will be strategically chosen based on revenue-generating potential in the specific facility. The division is successfully operating 14 electronic fee payment machines in high traffic facilities like Glen Alps trailhead in Chugach State Park and Chena River State Recreation Site in Fairbanks.

Increased revenue: The use of this system can increase fee generation at a facility by as much as 30% and, based on the locations under consideration, could generate upwards of \$100,000 in additional yearly program revenue.

Losses from vandalism: Recent years have seen increased vandalism of the cash-based "iron ranger" collection systems. These cash-based pay stations are a target for vandals, and costs associated with stolen cash along with repair and redesign costs for these pay stations are a burden to Division Field Operations.

Administrative liability and gained efficiency: The use of electronic fee stations will decrease the
