Agency Response Yes. DOC reverted to the process in place prior to lower cost office assistant positions being established. Correctional officers screen and process all inmate mail. These fall under “other duties as assigned” and are captured within the personal services of the assigned officer on shift. Officer payroll is funded via general funds. Screening and scanning of inmate mail limits contraband and is a critical safety precaution for both staff and inmates. While mail is not the highest contributor of contraband at this time, it is due to the diligent screening and processing of each item that enters the facility. When critical support duties from non-security positions are reassigned to Correctional Officers (COs), the result is typically increased overtime (OT) due to minimal security staffing levels. This occurs either because COs must be brought in specifically to complete those tasks, or because a CO performs the task during their shift, requiring another CO to cover the vacated post.
