## **House Finance Budget Subcommittee FY 11 Department of Fish and Game**

Subcommittee Report FY11

Date 2/28/10

The House Finance Budget Subcommittee on The Department of Fish and Game (ADF&G) submits an operating budget for FY11 as follows:

UGF \$58,108.0 DGF \$11,497.1 Fed Funds \$60,483.9 Other Funds \$56,896.2 Total \$186,985.2

## Department of Fish and Game House Finance Budget Subcommittee FY11 Highlights

The House Finance Budget Subcommittee's budget authorizes \$874.4 less general funds and the same number of employees as the Governor's amended FY11 Department of ADF&G request. The FY11 subcommittee budget requests a total increment from FY11 Adjusted Base of \$793.5 general funds.

The subcommittee remains concerned about low returns of salmon to the AYK region and accepted a fund source change from federal to general funds of \$130.0 to continue the Yukon River Chinook stock ID project.

The subcommittee also considered and approved two increments in the Wildlife Conservation component. With federal endangered species act implementation being a large concern in the state, the subcommittee approved a \$236.6 general fund increment for endangered species act listing coordination. Also, a \$250.0 general fund increment for intensive predator management control was considered and approved.

The subcommittee was concerned that federal receipts in the Pittman-Robertson fund may see a short-term increase but not necessarily so in the long-term.

Therefore a \$3,500.0 increment request was reduced to \$2,700.0 to better align long-term expenditures with expected long-term revenues.

Test fishing receipts were also reduced by \$924.4 to also better align the Department's authorization with anticipated expenditures.

The Governor requested that the Commercial Fisheries component have a single appropriation and allocation, the subcommittee disagreed and denied the structure change and continued with the same six allocations as last year.

A one-time item (OTI) of \$50.0 general funds was approved to fund a collaborative effort between the Department, industry and fishermen to research the biomass of the red king crab fishery in southeast. The red king crab fishery has only occurred in 3 of the past 10 years and better understanding of the biomass could lead to more accurate openings of the fishery and more revenue to the state.
